On behalf of the BCPSEA Board and staff, we hope you are having an enjoyable summer and looking forward with anticipation to the 2010-2011 school year.

Bargaining

Talk of change is in the air and we all know that support staff bargaining will be in full swing once the back to school period is behind us. As I mentioned in my last report to you, BCPSEA's role is one of support and expert resources, and the other of process management to ensure that agreements are concluded within the compensation mandate with terms that allow boards to carry out their mandates as boards.

Over the summer, further clarity will be brought to the public education policy direction, which will lead us to review the employment implications of the direction and how that will impact support staff bargaining. Last week, Vice Chair Alan Chell, Hugh Finlayson, and I had an opportunity to meet with Minister of Education Margaret MacDiarmid to discuss the bargaining reality. Prior to getting to the bargaining table, it will be necessary for us to review each of the 69 support staff bargaining plans, liaise with districts, and ensure that our sector is ready to bargain in the fall. While there is the potential for new structures and processes for bargaining, nothing will replace preparation and ongoing connection between districts and the employers' association throughout the 2010 rounds.

It is important to note that public sector bargaining to date has resulted in the following agreements consistent with the compensation mandate:

- SFU and SFU Faculty
- Health Employers' of BC and Community Health
- Health Employers' of BC and Facilities
- Public Service of BCGEU Master
- BC Hydro/IBEW
- Public Service and Professional Employees Association.

We also spoke with the minister about other key association initiatives. When there is talk about shared services, we need to remember that there are already many successful examples of services and innovations that school districts and the employers' association have put in place to assist other boards and the sector at large.
