How many students in your district have IEPs as a result of privately conducted psychoeducational assessments?

Do you have EAs that are trained in and provide Applied Behavior Analysis (ABA) or Intensive Behavioural Intervention (IBI)? If yes, how many?

How many custodians represented by CUPE does your district employ currently? How many in each year since 2006?

Has there been a workload increase for custodians in your district since 2006?

Does your district provide bus services for students travelling to and from school? If no, were these services provided by the district in the past?

If your district provides bus services for students, has there been a reduction in bus services compared to previous years?

Have bus services that were previously provided by unionized staff been contracted out to a non-union employer?


Do parents in your District pay for bus services? If yes, what is the cost of these services each year since 2010?
